RESOLUTION NO. 2013 - 005

**A RESOLUTION OF THE COUNCIL FOR THE BOROUGH OF NEWBURG
DELEGATING TO THE MAYOR THE DUTY TO ENFORCE THE BOROUGH'S PARKING
ORDINANCE ENACTED SEPTEMBER 17, 2012.**

WHEREAS, Borough Council on September 17, 2012, adopted Ordinance No. 2012-261, establishing parking regulations and enforcement procedures for violations of the Ordinance; and

WHEREAS, Ordinance No. 2012-261 provides that the Ordinance will be enforced by a parking enforcement officer to be designated by Borough Council; and

WHEREAS, Borough Council by Resolution No. 2012-~~0026~~ adopted October 1, 2012, appointed Commonwealth Code Inspection Service, Inc., to serve as the Borough's Parking Enforcement Officer; and

WHEREAS, the Mayor as set forth in Section 1007-A of the Pennsylvania Borough Code has the duty to enforce the Borough's ordinances, and to perform any other duties vested in the Mayor's office by ordinance; and

WHEREAS, Borough Council deems it in the best interest of the Borough to delegate to the Mayor the duty to enforce the Parking Ordinance; and


WHEREAS, Commonwealth Code Inspection Service, Inc. shall continue as the Parking Enforcement Officer.

NOW THEREFORE, BE IT RESOLVED by the Council for the Borough of Newburg as follows:

1. The above recitals are incorporated herein by reference hereto.
2. The Mayor is delegated the duty to enforce the Borough's Parking Ordinance, Ordinance No. 2012-261, and other parking ordinances to be adopted by Borough Council.
3. Effective Date: This Resolution shall become effective immediately.




